

PUBLIC AGREEMENT-OFFER
on the procedure for publishing authors' articles in the journal
" Art and Design"

Section 1. Purpose and Scope

1.1. This Public Agreement (hereinafter – the Agreement) establishes the procedure for the submission, processing, and publication of authors' articles in the journal " Art and Design."

1.2. The Agreement is addressed to an indefinite number of persons and applies to every author who has accepted its terms.

Section 2. Public Offer and Access to the Text

2.1. This Agreement constitutes a public offer pursuant to Article 633 of the Civil Code of Ukraine.

2.2. The current version is published at: <https://art-design.com.ua/uk/license-agreement>.

2.3. The publication of this text on the official website of the journal constitutes an offer to conclude the Agreement under the conditions set forth herein.

Section 3. Parties and Roles

3.1. The Author is a natural person who has created an article and submits it for publication; within the Agreement – the Licensor.

3.2. The Publisher/Editorial Office of the Journal is the organisation that carries out editorial processing and publication; within the Agreement – the Licensee.

Section 4. Accession (Acceptance) and Preconditions

4.1. The Agreement is concluded by the Author's full and unconditional acceptance of its terms, without any reservations or exceptions (Article 642 of the Civil Code of Ukraine).

4.2. Before acceptance, the content of the article shall be preliminarily agreed upon between the Author and the Editorial Office.

4.3. The act of acceptance is the Author's submission of materials for publication in the Licensee's journal.

Section 5. Licensing Terms (CC BY) and Scope of Rights

5.1. The Author retains personal non-property and property copyright to the work.

5.2. The Author grants the Licensee the right of first publication under the terms of the Creative Commons Attribution International Licence (CC BY).

5.3. Within the scope of this licence, the Licensee is authorised to:

- publish articles in English and distribute their printed versions;
- translate articles written in Ukrainian into English and distribute printed versions of the translation;
- distribute electronic versions of articles, as well as English translations (for articles in Ukrainian), through any electronic means (the official journal website, electronic databases, repositories, etc.).

Section 6. Confirmation of Acceptance and Allocation of Rights

6.1. The act specified in clause 4.3 constitutes acceptance of the Agreement's terms.

6.2. The publication of the author's material in the journal "Technologies and Engineering" serves as confirmation of the allocation of rights between the Licensor and the Licensee.

Section 7. Liability of the Parties

7.1. In the event of failure or improper performance of obligations, the parties shall be liable in accordance with the current legislation of Ukraine.

Section 8. Dispute Resolution

8.1. Disputes and disagreements shall be resolved through negotiations between the parties.

8.2. If no agreement is reached, the dispute shall be subject to judicial consideration in accordance with the legislation of Ukraine.

Section 9. Final Provisions

9.1. In all matters not regulated by this Agreement, the parties shall be governed by the legislation of Ukraine.

9.2. Updates to this Agreement shall take effect from the moment of their publication at the address indicated in clause 2.2.

9.3. The Agreement enters into force for a particular Author from the moment of acceptance as defined in clause 4.3.
